

MOTION TO STRIKE
COMPLAINANT'S REFERRAL
TO EVIDENTIARY PARTY


Complainants Gehring and Jones (hereafter "Complainants") have filed a Formal Complaint into Docket No. W-03514A-12-0008 based on previously submitted informal complaints number 2011-98439 and 2011-98782. Complainant's, as part of the Formal Complaint documents submitted in support thereof, have included substantial evidence based on erroneous facts that has material significance to this matter.

At Complaint section B (23), (25), and (26), portions of Exhibits A, B, and C, and portions of Appendix A are based upon an interview between Complainant's and Martin's Trucking Service Co. Substantial allegations are made and argument offered related to this interview which alleges a business contractual relationship with Payson Water Co., Inc. ("Payson"). In fact, Payson has no written or verbal business relationship or contract with Martin's Trucking Service Co.

1 As a result of Complainant's reference Company is placed at a serious
2 disadvantage in replying to Complainant's allegation based on an entity it has no
3 relationship with. As a consequence, Payson cannot submit data requests, ask questions,
4 interrogate, or make references to entities with which it has no business relationship as it
5 relates to the Augmentation Period. Further, Complainant offers no foundation in the
6 form of contractual agreements, invoices, driver log books, interview notes, or other
7 documents that substantiates its allegations of any contractual arrangement. As such,
8 Complainant's allegations and reference to Martin's Trucking Service Co. can only be
9 regarded, at best, as hearsay.

10 As a result Company files this Motion to Strike the submission as part of the
11 Complaint and related argument and asks that it be stricken from the record as well as
12 prohibiting Complainant's from using the information at Hearing until Complainant
13 establishes a relevant business relationship in connection with the Company.


