Pursuant to Arizona Corporation Commission (Commission) Decision No. 72737, APS is required to:

On the day that any trigger is activated, APS will notify the solar industry by e-mail and APS will provide a similar notice on its website. The mechanics of the residential triggers would include timely notification to the Commission and installers if the trigger is reached.
Decision No. 72737, page 6, FOF 21.

APS hereby notifies the Commission and interested parties that the second residential incentive trigger for 2012 is being activated effective today, March 22, 2012. Therefore, in accordance with Table 2 on page 6 of Decision No. 72737, the Company's up-front incentive level for residential solar photovoltaic installations has been reduced by 5 cents to \$0.55 per watt.
