PROCEDURAL ORDER

BY THE COMMISSION:

By Procedural Orders dated January 17, 2012, and March 9, 2012, dates for filing testimony in the above-captioned matter were set. Under the revised schedule, the date for rebuttal testimony and associated exhibits on behalf of CenturyLink, or by Staff or intervenors to testimony other than CenturyLink's was set as April 16, 2012.

On April 9, 2012, CenturyLink filed an Unopposed Motion to Modify Testimony Filing Date, requesting that the April 16, 2012, deadline be extended to April 23, 2012. The Motion states that the additional time will give parties time to narrow the issues and will not delay the hearing, currently set to begin April 30, 2012.

No party opposed the motion

IT IS THEREFORE ORDERED that the **deadline to file rebuttal testimony** and associated exhibits to be presented at hearing on behalf of CenturyLink, or by Staff or intervenors to **testimony other than that of CenturyLink**, shall be reduced to writing and filed on or before **April 23, 2012**.




