**JOINT MOTION FOR CONSOLIDATION

The Utilities Division ("Staff") of the Arizona Corporation Commission ("Commission") and Eagletail Water Company, L.L.C. ("Company") hereby move to consolidate Docket No. W-03936A-11-0418, *In the Matter of the Application of Eagletail Water Company, L.L.C. for a Permanent Rate Increase* ("rate application"), with Docket No. W-03936A-12-0073, *In the Matter of the Application of Eagletail Water Company, L.L.C. for Approval of a Long Term Loan and Grant* ("financing application").


The Commission's rules at A.A.C. R14-3-109.H., permit consolidating two or more proceedings when the issues are substantially the same and consolidation will not prejudice the parties. The issues in these two matters are substantially related and consolidation will not prejudice the rights of any party. Staff's preliminary review of the Company's financing application indicates that it is unlikely that Company will be able to service the debt under Staff's recommended rates. The parties believe that consolidation of these matters will aid in the Commission in the evaluation of both matters.

In addition the parties request a brief suspension of the time clock in Docket No. 11-0418. The Parties are filing separate motions in each of these dockets requesting this consolidation and brief suspension of the time clock.

Although Staff is filing this motion, Staff has conferred with the Company and the Company is in agreement with these requests. Staff will make every effort to process the Company's Financing

1 Application and provided a revised recommendation regarding the Company's rate application, if  
2 necessary, in a timely manner.
