**MOTION FOR EXTENSION
OF TIME**

Water Utility of Northern Scottsdale ("WUNS") respectfully moves for an extension of time to file its next rate case. Under Decision No. 70562 (October 23, 2008), WUNS was required to "file a general rate case application on or before April 30, 2012, using a test year ended December 31, 2011."¹ WUNS requests that this deadline be extended until August 30, 2012.

WUNS's ultimate parent company is Global Water Resources, Inc. ("Global"). Global's other operational utilities are working on a rate case filing, which they intend to file on or before June 30, 2012.² A short extension of time would allow WUNS to be included in a consolidated rate case. That would be more efficient, because many of the issues will be common to each applicant in the consolidated rate case. A due date of August 30, 2012 would provide a prudent extra cushion of time in the event there were any unforeseen delays in filing the consolidated case.


