**SECOND  
PROCEDURAL ORDER**  
**(Schedules Pre-hearing Conference)**

BY THE COMMISSION:

On March 30, 2012, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against SEED Corporation ("SEED"), Randall Duane Simonson and Marilyn J. Simonson, husband and wife, and Karl Henry Rehberg aka Shawn Pierce, and Helen Rehberg aka Lisa Pierce, husband and wife (collectively "Respondents"), in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of stock and notes.

The Respondent Spouses, Marilyn J. Simonson and Helen Rehberg aka Lisa Pierce, were joined in the action for the purpose of determining the liability of the marital communities pursuant to A.R.S. § 44-2031(C).

The Respondents were duly served with copies of the Notice.

On April 13, 2012, Respondents Randall Duane Simonson and Marilyn J. Simonson filed a request for hearing in this matter.

2       On May 3, 2012, Respondents Karl Henry Rehberg and Helen Rehberg filed requests for  
3 hearing in this matter.

4       Accordingly, a second pre-hearing conference should be scheduled.

5       IT IS THEREFORE ORDERED a **pre-hearing conference** on the request by the Simonson  
6 Respondents shall be held on **May 9, 2012, at 11:00 a.m.**, at the Commission's offices, 1200 West  
7 Washington Street, Hearing Room No. 2, Phoenix, Arizona, as previously ordered.

8       IT IS FURTHER ORDERED that a **second pre-hearing conference** shall be held on the  
9 requests by the Rehbergs on **May 30, 2012, at 11:00 a.m.**, at the Commission's offices, 1200 West  
10 Washington Street, Hearing Room No. 2, Phoenix, Arizona.

11       IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113-Unauthorized  
12 Communications) is in effect and shall remain in effect until the Commission's Decision in this  
13 matter is final and non-appealable.

14       IT IS FURTHER ORDERED that all parties must comply with Rules 31 and 38 of the Rules  
15 of the Arizona Supreme Court and A.R.S. § 40-243 with respect to the practice of law and admission  
16 *pro hac vice*.

17       IT IS FURTHER ORDERED that withdrawal or representation must be made in compliance  
18 with A.A.C. R14-3-104(E) and Rule 1.16 of the Rules of Professional Conduct (under Rule 42 of the  
19 Rules of the Arizona Supreme Court). Representation before the Commission includes appearances  
20 at all hearings and procedural conferences, as well as all Open Meetings for which the matter is  
21 scheduled for discussion, unless counsel has previously been granted permission to withdraw by the  
22 Administrative Law Judge or the Commission.


