Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

- 1. On February 21, 2012, the Commission issued Decision No. 72897, which approved a Settlement Agreement that contained new rates and charges for Goodman Water Company ("Goodman" or "Company").
2. The rates and charges were attached as an exhibit to the Settlement Agreement, which in turn, was attached as Exhibit A to Decision No. 72897, and incorporated therein. The schedule of rates and charges did not identify the break-over points for gallons used when calculating the charges for the 8 inch and 12 inch meters.
3. On March 7, 2012, Goodman filed a Motion for Entry of Procedural Order Nunc Pro Tunc correcting Decision No. 72897 to include the tier break-over points for the 8 inch and 10 inch meters.
