STAFF'S REQUEST FOR WAIVER

Pursuant to A.A.C. R14-2-704(A), the Utilities Division ("Staff") of the Arizona Corporation Commission ("Commission") must file, by October 1, 2012, a Staff Report containing its analysis and conclusions regarding its statewide review and assessments of the Integrated Resource Plan filings submitted by Arizona Public Service Company ("APS"); Tucson Electric Power Company ("TEP"); UNS Electric Inc. ("UNS Electric"); and Arizona Electric Power Cooperative, Inc. ("AEPCO") in the above-referenced matter. To assist Staff in the preparation of its Staff Report, Staff retained the services of Global Energy & Water Consulting, LLC ("consultant") on June 19, 2012.

After discussing the scope of the Staff Report with its consultant, Staff has learned that it will need additional time to file its Staff Report. While Staff will endeavor to file its Staff Report as soon as practical, Staff respectfully requests that the Commission waive A.A.C. R14-2-704(A) and allow Staff to file its Staff Report no later than December 1, 2012.
