
On September 26, 2007, Intellicall Operator Services, Inc. dba ILD Telecommunications, Inc. and Andiamo Telecom, L.L.C. filed a Notification of an Asset Purchase Agreement. On May 11, 2012, staff filed a memorandum noting that in Decision No. 72710, Andiamo Telecom, L.L.C.'s application to cancel its CC&N was approved. Staff recommends that these dockets be administratively closed since Andiamo Telecom, L.L.C. no longer provides service in Arizona.

Per the Procedural Order on May 25, 2012, by Belinda A. Martin, Administrative Law Judge, staff's recommendation is reasonable and these dockets shall be administratively closed. Therefore, these dockets are administratively closed.
