On May 23, 2002, the University of Arizona ("UofA") filed an application for a declaratory order directing Tucson Electric Power Company ("TEP") to make available all electric rates for which UofA qualified. On September 19, 2002, a procedural order was issued stating that an agreement between UofA and TEP had been filed in Docket No. E-01933A-02-0670 and that approval of the agreement would resolve the issues in this docket. On October 16, 2002, in Decision No. 65274, the agreement between UofA and TEP was approved.

Per the memorandum on July 20, 2012 by Steven M. Olea, Director of the Utilities Division, the procedural order on September 19, 2002 was the last filing in this docket and no additional filings are anticipated. There is no longer a reason for Docket No. E-01933A-02-0388 to remain open and staff requests that it be administratively closed. Therefore, this docket is administratively closed.
