STIPULATION BETWEEN ALECA AND BUDGET PREPAY, INC.

Budget Prepay, Inc. ("Budget") and the Arizona Local Exchange Carriers Association ("ALECA") submit the following stipulation concerning Budget's Application in this docket.

1. ALECA has intervened in this docket to address potential concerns about the Application.

2. To address ALECA's potential concerns, Budget agrees that it will not provide Lifeline or LinkUp service to eligible residents residing on the lands of a Federally Recognized Tribe in Arizona until Budget has obtained any and all necessary licenses or other forms of approval that may be required by a Tribe. Before providing such service on tribal lands, Budget will file a copy of the tribal license or other form of approval with the Arizona Corporation Commission in Docket No. T-04079A-11-0362, with a copy to ALECA's undersigned counsel.
