PROCEDURAL ORDER

**BY THE COMMISSION:**

On May 4, 2012, counsel for Pac-West Telecomm, Inc. ("Pac-West") filed a Motion to Continue Oral Argument that was set for May 18, 2012.

On May 8, 2012, the Arizona Corporation Commission ("Commission") Utilities Division ("Staff") filed a Request for Extension to File Supplement Authority or Supplemental Arguments. Staff requested that the date for filing supplemental authority be continued until ten days prior to the revised oral argument date.

Although CenturyLink originally expressed opposition to continuing the oral argument, the parties have subsequently agreed that continuing the matter until June 12, 2012 would be acceptable, with a commensurate extension of the time to file supplement authority.

1 IT IS THEREFORE ORDERED that oral argument in this matter shall be continued to  
2 June 12, 2012, at 10:00 a.m., or as soon thereafter as is practical, at the Commission's Tucson  
3 Offices, Room 222, 400 West Congress St. Tucson, Arizona 85701.

4 IT IS FURTHER ORDERED that the deadline to file Supplement Authority is extended  
5 until June 4, 2012.

6 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive  
7 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
