
Qwest Corporation ("Qwest") objects to the Complainant's Discovery Requests which were filed in the Docket on May 11, 2012 (the "Discovery Requests"). In support of this objection, Qwest states:

1. The Complainant has failed to file written testimony by May 3, 2012, the date required by the Commission's February 10, 2012 Procedural Order. This is the second time the Complainant has ignored a Commission order to file written testimony. It is unjust and burdensome to require Qwest to answer Complainant's lengthy requests when the Complainant has repeatedly failed to prosecute his own case.

2. A Motion to Dismiss is pending. An order granting the Motion to Dismiss in whole or in part may obviate the need for some or all of the Discovery Requests.
