**CENTURYLINK'S UNOPPOSED MOTION TO WITHDRAW THE SETTLEMENT AGREEMENT BETWEEN CENTURYLINK AND THE DEPARTMENT OF DEFENSE AND ALL OTHER FEDERAL EXECUTIVE AGENCIES FROM COMMISSION CONSIDERATION**

Qwest Corporation d/b/a CenturyLink-QC ("CenturyLink"), acting in accordance with its commitment made in the Settlement Agreement between and among CenturyLink, the Arizona Corporation Commission Utilities Division Staff, the Residential Utility Consumer Office, and the Arizona Investment Council (the "Global Settlement"),<sup>1</sup> moves to withdraw from consideration in this Docket the Settlement Agreement and Stipulation between CenturyLink and the United States Department of Defense and all other Federal Executive Agencies (the "DoD Settlement").

The DoD Settlement was filed in this Docket on April 19, 2012. However, under Section 2.11 of the Global Settlement, CenturyLink agreed with the aforementioned parties to the Global Settlement to withdraw the DoD Settlement from Commission consideration in this Docket.


