As a part time resident of Verrado in Buckeye, AZ. I am writing to comment on Arizona American Water's plan to de-consolidate its Anthen/Aqua Fria Wastewater District into two separate wastewater districts. Verrado would be located in the new Agua Fria Wastewater District. Oour sewer rates just increased by 53.98% in January 2011 and if the de-consolidation went forward, we would see an overall increase of 139.7 for the Agua Fria Wastewater District while lowering the Anthem Wastewater District rate increase to 15.5%

I oppose the de-consolidation. The Commission' order on the January 6, 2011 that Arizona American develop a consolidation proposal that includes all of its systems in a future rate application. Maintaining consolidated systems will include benefits including lower administrative and rate case expenses, improved rate stability, and reduced customer confusions. This is like a double - whammy as we also looking at a possible increase of 83% in our water rates. As a retired person on a limited income, these increases are shocking. I will be attending the public comment session on October the 17th, 2011, but wanted to add my comment as well. Diana Lingholt
