Procedural Order

BY THE COMMISSION:

By Procedural Order dated May 15, 2012, a hearing was scheduled in this matter to commence on July 11, 2012, and continuing on July 12 and 13, 2012, if needed. In addition, various procedural deadlines were established, including the publication of notice.

On May 17, 2012, Tucson Electric Power Company ("TEP") filed a Request Regarding Witness Appearance. TEP requested that because one of its witnesses was out of state on the first two days of the scheduled hearing, that she either be allowed to testify telephonically on July 11 or 12, 2012, or appear in person on July 13, 2012.

No party objected to TEP's request, nor requested other changes in the schedule that would warrant altering the form of public notice set forth in the May 15, 2012 Procedural Order.

IT IS THEREFORE ORDERED that whether the TEP witness will appear telephonically or in-person will be discussed during the July 9, 2012, pre-hearing conference.

IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


