PROCEDURAL ORDER

BY THE COMMISSION:

On March 11, 2011, the Arizona Corporation Commission ("Commission") opened this docket for the purpose of filings related to Resource Planning and Procurement in 2011 and 2012.

On May 11, 2012, Arizona Competitive Power Alliance (the "Alliance") filed a Motion to Intervene.

To date no objections have been filed and accordingly, the Alliance should be granted intervention.

IT IS THEREFORE ORDERED that Alliance is hereby granted intervention.

IT IS FURTHER ORDERED that all parties must comply with Arizona Supreme Court Rules 31 and 38 and A.R.S. § 40-243 with respect to practice of law and admission *pro hac vice*.

IT IS FURTHER ORDERED that withdrawal of representation must be made in compliance with A.A.C. R14-3-104(E) and Rule 1.16 of the Rules of Professional Conduct (under Arizona Supreme Court Rule 42). Representation before the Commission includes the obligation to appear at all hearings and procedural conferences, as well as all Open Meetings for which the matter is scheduled for discussion, unless counsel has previously been granted permission to withdraw by the Administrative Law Judge or the Commission.

IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend, or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
