**PROCEDURAL ORDER**

**BY THE COMMISSION:**

On September 26, 2007, Intellicall Operator Services, Inc. d/b/a ILD Telecommunications, Inc. and Andiamo Telecom, L.L.C. ("Applicants") filed with the Arizona Corporation Commission ("Commission") Notification of an Asset Purchase Agreement.

On October 22, 2007, the Commission's Utilities Division Staff ("Staff") filed its Letter of Insufficiency and First Set of Data Requests.

On January 25, 2008, Staff filed another Letter of Insufficiency and Second Set of Data Requests.

On April 2, 2012, a Procedural Order was filed directing Staff to file an update on the status of the dockets.

On April 25, 2012, the Applicants filed their Responses to Staff's Data Requests.

On May 11, 2012, Staff filed a Memorandum noting that in Decision No. 72710 (December 9, 2011) the Commission approved Andiamo Telecom, L.L.C.'s application to cancel its CC&N for alternative operator services, competitive resold local exchange and interexchange telecommunication services in Arizona. Because Andiamo Telecom, L.L.C. is no longer providing service in Arizona, Staff recommends that these dockets should be administratively closed.




