
NOTICE OF COMPLIANCE FILING

8 Decision No. 73146 (the "Decision") was docketed on May 1, 2012 in the above-captioned
9 dockets. The seventh ordering paragraph of the Decision, at page 49, ordered Arizona Water Company
10 (the "Company") to file with Docket Control a statement regarding whether the Company believes its
11 Formal Complaint (filed on March 29, 2006, docketed in Docket No. W-01445A-06-0200, and
12 subsequently consolidated with certain of the other Dockets listed above) should be dismissed.

13 The Company docketed on May 31, 2012, a Joint Motion to dismiss its Formal Complaint based
14 upon the terms of the Company's May 15, 2008 Settlement Agreement with Global Water Resources,
15 Inc.. For the reasons stated in that motion, the Company believes that the Commission should dismiss its
16 Formal Complaint, without prejudice.
