**RESPONDENT'S REQUEST FOR A SECOND CONTINUANCE FOR A
HEARING REGARDING PROPOSED ORDER TO CEASE AND
DESIST, FOR RESTITUTION, AND FOR ADMINISTRATIVE
PENALTIES**

AND NOW, this 18th day of June, 2012, comes Andrew C. Menichino, Pro Se,
Individually and as a Director of Innovative Construction, Inc., a Pennsylvania Corporation,
and Atlantic Lexus, Ltd., a Turks and Caicos Corporation, and files this Request for a
Continuance for a Pre Hearing Conference Regarding Proposed Order to Cease and Desist, for
Restitution, and for Administrative Penalties, as follows:

1. On March 28, 2012, service of Notice of Opportunity for Hearing Regarding
Proposed Order to Cease and Desist, for Restitution, and for Administrative Penalties was

served upon Respondent, Andrew C. Menichino by Daniel E. Meinert, Securities Investigator, Pennsylvania Securities Commission, while Respondent was attending a Workers' Compensation Hearing at the PA Career Link Beaver County, Conference Room, 285 Beaver Valley Mall, Route 18, Monaca, Pennsylvania 15061.

2. Respondent, Andrew C. Menichino, received notice on April 19, 2012 of a Pre Conference Hearing scheduled for May 16, 2012 that was subsequently rescheduled for June 21, 2012.

3. Respondent Andrew C. Menichino continues to have difficulty scheduling, with such short notice, coordinating local representation *pro hac vice* and Representation in Arizona for the hearing on June 21, 2012.

4. Respondent Andrew C. Menichino is requesting a second continuance of thirty to forty five days or later in order to facilitate Representation on this matter.

5. Respondent Andrew C. Menichino has sold property that was to close June 15, 2012, but the closing has been postponed for two weeks. Respondent has made other arrangements for funds, but will not have that funding for two more weeks.

6. Respondent has been working with local counsel, Attorney Carmen Lamancusa of New Castle, PA, who is trying to arrange for proper representation in Arizona, but as of this date, has not completed those arrangements.

7. It is the intention of Respondent to obtain counsel in Arizona in order to file an Answer regarding the Proposed Order to Cease and Desist, for Restitution, and for Administrative Penalties.

WHEREFORE, Respondent, Andrew C. Menichino, pro se, requests a second thirty day or more Continuance for a Pre Hearing Conference regarding the Proposed Order to Cease and Desist, for Restitution, and for Administrative Penalties.
