BY THE COMMISSION:

Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

1. On May 18, 2012, the Arizona Corporation Commission ("Commission") issued Decision No. 73161, in this matter granting Eagletail Water Company, L.L.C. ("Eagletail" or "Company") a rate increase, and approving the Company's request for financing approval.

2. On June 8, 2012, the Commission's Utilities Division ("Staff") filed a Motion for an Order Amending Decision No. 73161 Nunc Pro Tunc to correct two clerical errors contained in the Decision.

3. Staff points out that the Order in Decision No. 73161, on pages 5 and 16, incorrectly references the service charge for fire sprinklers rather than referring to Arizona Administrative Code ("A.A.C.") R14-2-409(G).

CONCLUSIONS OF LAW

- 1. Eagletail is a public service corporation within the meaning of Article XV of the Arizona Constitution and A.R.S. §§ 40-250, 40-251, 40-302, and 40-303.
- 2. The Commission has jurisdiction over the Company and the subject matter of the applications.
- 3. Staff’s request to amend Decision No. 73161 to correct two clerical errors is reasonable and should be approved.

ORDER

IT IS THEREFORE ORDERED that Decision No. 73161 is hereby amended at page 5, lines 8.5 to 9.5, and page 16, lines 20 to 21, to delete the references to service charges to fire sprinklers and to insert “Per Commission Rule A.A.C. R14-2-409(G).”

1 IT IS FURTHER ORDERED that in all other respects, Decision No. 73161 shall remain in
2 full force and effect.

3 IT IS FURTHER ORDERED that this Decision shall become effective immediately.


