

On behalf of Park Valley Water Company/Fools Hollow Water Company and the City of Show Low, I would like to express our collective appreciation for the prompt and efficient manner in which the Applications which are the subject of the above-referenced dockets were processed by the Commission's Utilities Division and Hearing Division and readied for a decision by the Commission at its forthcoming July 18-19, 2012 Regular Open Meeting.

More specifically, Park Valley filed its Application on February 6, 2012 and Fools Hollow filed its Application on February 23, 2012. A Sufficiency Letter was issued by the Utilities Division on April 4, 2012, and an evidentiary hearing on the aforesaid Applications was held on June 11, 2012. Thereafter, a Recommended Opinion and Order recommending approval of the actions of the Commission requested in the aforesaid Applications was issued on July 2, 2012, or 21 days following conclusion of the evidentiary hearing.

This case represents an excellent example of regulation at its finest, and we believe that the involved members of the Commission's Staff are to be commended in that regard.
