Budget Prepay, Inc. (“Budget” or the “Company”) hereby files this Second Amendment to its pending Application for Arizona Corporation Commission (“Commission”) designation as a non-rural wireless Eligible Telecommunications Carrier (“ETC”).¹ Budget files this Second Amendment solely for the purpose of correcting its trade name or “doing business as” name from “d/b/a Budget Phone, Inc.” to “d/b/a Budget Mobile, Inc.”. 
