9. Staff has suggested that if the Commission approves the Rate Base Reduction Tariff, the Commission should require Arizona-American to submit an annual report to Docket Control that lists the entities that have paid the tariff and how much they have paid. The report should be filed each July beginning in 2007, and should cover the previous 12 months.

10. We believe that the Rate Base Reduction Tariff, as outlined in Staff's Memorandum should be approved.

CONCLUSIONS OF LAW

1. Arizona-American Water Company provides water utility service to residents within the State of Arizona pursuant to multiple certificates of convenience and necessity issued by the Arizona Corporation Commission.

2. The Commission has jurisdiction over Arizona-American Water Company, and the subject matter in this Application.

3. Staff's recommendations in Findings of Fact Nos. 8 and 9 are reasonable and should be adopted.

4. The Commission, having reviewed the filing and Staff's Memorandum dated June 8, 2006, finds that it is in the public interest to approve the Rate Base Reduction Tariff and the supporting requirements outlined in Finding of Fact No. 9.

ORDER

IT IS THEREFORE ORDERED that the Rate Base Reduction Tariff as discussed herein be and hereby is approved.
