1 On March 10, 2012, Far West Water & Sewer Company ("Far West") filed a
2 motion to withdraw its application in the above-captioned docket. By a Procedural Order
3 dated April 14, 2010, Far West's motion was "held in abeyance pending the submission
4 of a future rate case."

5 On July 5, 2012, Far West submitted an application to increase its sewer rates in
6 Docket No. WS-03478A-12-0307. By a Letter dated August 3, 2012, the Staff of the
7 Commission's Utility Division found Far West's rate application to be "sufficient" per
8 section R14-2-103.B.7 of the Arizona Administrative Code. Therefore, Far West moves
9 to close the above-captioned docket.
