**NOTICE OF JOINT FILING OF REVISIONS TO PROPOSED  
PROCEDURAL SCHEDULE**

The Residential Utility Consumer Office ("RUCO") provides the following notice regarding a proposed procedural schedule in the above matter. On August 3, 2012, Staff and TEP filed a Joint Request for Procedural Schedule. On August 6, 2012, RUCO filed a Response to the Joint Request. Since the filings Staff, RUCO and TEP have discussed the issue and have agreed on the following proposed procedural schedule (the only difference from the original Joint Request being that Settlement Discussions are to commence on January 15, 2012, instead of January 10, 2012 and the discussion would conclude by January 22, 2012 instead of January 18, 2012).






