**REQUEST TO MODIFY
PROCEDURAL SCHEDULE**

13 Applicant, Rio Rico Utilities, Inc. ("RRUI" or the "Company") hereby submits this
14 Request to Modify Procedural Schedule in the above-referenced matter.

15 The Rate Case Procedural Order in this docket was signed on July 13, 2012, with
16 the hearing being scheduled to commence on March 26, 2013. The key dates were agreed
17 upon by Staff and the Company. Counsel for the Company, however, neglected to
18 mention an existing personal conflict on March 26, 2013, and hereby asks that the
19 procedural schedule be modified slightly.

20 Towards that end, counsel has conferred with counsel for Staff and RUCO and all
21 parties have indicated that they are available to commence the hearing in this case on
22 Wednesday, March 27, 2013, continuing through to March 29, 2013 if necessary.
23 Accordingly, and subject to the availability of the Presiding Officer and the Commission,
24 the Company respectfully requests that the rate case procedural schedule be modified as
