- 1. THE MONTHLY WATER RATES ARE UNREASONABLE**
- 2. THE 11.5% RATE OF RETURN ARE UNREASONABLE**
- 3. THE STAFF USED ONLY THE YEAR 2011 AS THE TEST YEAR WHEN PREVIOUS YEARS INDICATED FAR LESS EXPENSES WHICH SHOULD HAVE BEEN USED TO AVERAGE A FAIR RATE INCREASE.**
- 4. A REQUEST TO RULE ON THE SERVICE FEE AS A MAINTENANCE FEE WAS NOT ANSWERED.**
- 5. NO ANSWER GIVEN IN RESPONSE TO, EXPENSES RELATED TO THE SECOND WELL SHOULD NOT BE ALLOWED IN THE TEST YEAR AS IT IS NOT PART OF THE CURRENT SYSTEM.**
- 6. NO RESPONSE FOR SUNLAND WATER BEING IN VIOLATION OF RULE R18-4-503A**
- 7. NO ANSWER WAS GIVEN CONCERNING THE LEAD CONTENT IN THE SECOND WELL AND ONLY A STATEMENT GIVEN IN PARAGERAPH 57 OF THE FINAL DECISION CONCERING NITRATES.**
