PUBLIC NOTICE OF ARIZONA CORPORATION
COMMISSION DECISION NO. 73261
APPROVING MORENCI WATER AND
ELECTRIC COMPANY'S APPLICATION FOR AN
ADJUSTMENT IN ITS PURCHASED POWER AND
FUEL ADJUSTMENT CLAUSE

On July 30, 2012, the Arizona Corporation Commission issued Decision No. 73261 regarding Morenci Water and Electric Company ("MWE") and its Purchased Power and Fuel Adjustment Clause ("PPFAC"). That decision approves an adjustment to MWE's PPFAC rate. Currently, MWE's PPFAC rate is negative \$0.05100 per kilowatt hour (kWh). The Company had proposed an increase in the PPFAC rate to negative \$0.03122 per kWh to address a rapidly-increasing under-collected bank balance. The Commission approved an increase in the rate to negative \$0.03449 per kWh to take effect starting September 1, 2012. Based on monthly average use of 657 kWh, the residential customer's bill will increase by approximately \$10.85 per month.
