BY THE COMMISSION:

On July 2, 2012, Tucson Electric Power Company ("TEP") filed with the Arizona Corporation Commission ("Commission") an Application for a rate increase.

On August 13, 2012, TEP, the Residential Utility Consumer Office ("RUCO") and the Commission's Utilities Division ("Staff") filed a Revised Proposed Procedural Schedule.


