BY THE COMMISSION:


In Docket No. E-01933A-11-0055, "In the Matter of the Application of Tucson Electric Power Company for Approval of its 2011-2012 Energy Efficiency Implementation Plan," Tucson Electric Power Company ("TEP") proposed a change to the Demand Side Management Surcharge ("DSMS") mechanism which was approved in the above-captioned dockets as part of the 2008 Rate Case Settlement Agreement.

As a party of record to the 2008 Rate Case, you are receiving a copy of the Recommended Opinion and Order in Docket No. E-1933A-11-0055 ("EE ROO"), with this Procedural Order. The Commission will consider the EE ROO at a future Open Meeting as indicated on the EE ROO cover sheet. The EE ROO recommends re-opening the above captioned dockets pursuant to A.R.S. §40-252, in order to consider the proposed modifications to the DSMS. If you have comments or objections to the EE ROO, file them as Exceptions to the EE ROO in Docket No. E-1933A-11-0055, by the deadline indicated on EE ROO cover page. You need not take any action, but failure to file

1 Exceptions may result in the re-opening of the 2008 Rate Case and modification of the DSMS as
2 discussed in the 2011 EE ROO.

3 IT IS THEREFORE ORDERED that parties to the 2008 Rate Case are hereby on notice that
4 the Commission may re-open Dockets No. E-01933A-07-0402 and E-01933A-05-0650 and Decision
5 No. 70628 pursuant to A.R.S. §40-252, for the sole purpose of re-examining and potentially
6 modifying the DSMS; parties shall file any comments or objections in the form of Exceptions to the
7 EE ROO in Docket No. E-01933A-11-0055 by the exception deadline; and may appear to be heard at
8 the Open Meeting at which the EE ROO will be discussed.
