BY THE COMMISSION:

On this date, a Procedural Order and the Recommended Opinion and Order ("ROO") filed in this docket are being sent to the parties of record in Dockets Nos. E-01933A-07-0402 and E-01933A-05-0650, Tucson Electric Power Company's ("TEP") 2008 Rate Case, as notice that the ROO recommends that the Arizona Corporation Commission ("Commission") re-open the 2008 Rate Case pursuant to A.R.S. §40-252 for the sole purpose of considering the proposed modifications to the DSM Surcharge.
