T.E.P.'s electric meter failed, causing my building's electric bill to increase several-fold, as reflected in the bills for April & May, 2012. After the meter was replaced, the bills returned to levels consistent with temperature, occupancy, and usage. This was in violation of T.E.P.'s obligation pursuant to A.R.S. Sec. 40-361 & A.A.C. R14-2-208(b).
