18 Respondents, Out of the Blue Processors, LLC. and Mark Steiner MOVE for an Order  
19 vacating the hearing at present scheduled for October 4, 2010 at 9:30 a.m. and rescheduling the  
20 same on a date convenient for the Commission and the Hearing Officer on or after October 24,  
21 2012. In support of their motion, Respondents, by counsel, show:

22 Respondent Steiner has been out of the country, in China and Nigeria, during more than  
23 half of August and September, and did not return until this past weekend. As a result, he has not  
24 been physically present in Phoenix where he could meet with counsel and assist counsel in  
25 preparing for a hearing. Neither was he able, under the circumstances of his travels, to advise


1 counsel of the details of the events occurring while he was so engaged or to schedule time with  
2 counsel in advance of this week so that this week could be used to prepare. It will, accordingly,  
3 take into next week or longer to prepare for the hearing.

4 A formal interview of Respondent Steiner is at present proposed for October 17, 2012 by  
5 the Securities Division staff. Steiner has agreed to the date.

6 Respondents respectfully suggest that it is pointless to hold a further hearing until such an  
7 interview has occurred and until the further substantial progress toward completion of the  
8 proposed transactions involved with this matter have been properly documented and demonstrated  
9 to the Commission. It also is respectfully suggested that the further hearing in this matter should  
10 occur at least a week after the formal interview to permit such agreement as may prove to be  
11 possible.
