**BY THE COMMISSION:**

On July 2, 2012, Tucson Electric Power Company ("TEP") filed for approval of its 2013 Renewable Energy Standard Implementation Plan (the "Implementation Plan") with the Arizona Corporation Commission ("Commission").

On September 20, 2012, Arizona Solar Energy Industries Association ("SEIA") filed an Application for Intervention in this matter.

SEIA states that it is a non-profit trade association representing local, national, and international solar companies from all industry sectors in the Arizona market, and that TEP's Implementation Plan includes numerous provisions that will substantially and directly impact the policies, economics and mechanics of the solar business and the interests of SEIA members.

No party objected to SEIA's intervention.

IT IS THEREFORE ORDERED that SEIA's request to intervene is granted.
