**KNOW ALL MEN BY THESE PRESENT;** that we, Sacramento Utilities, LLC, 6307 Monterey Place, Littleton, CO 80130, as Principal, hereinafter called "Principal" and Southwest Marine and General Insurance Company, a corporation, organized and existing under the laws of the State of Arizona, with principal offices at 2307 River Road, Suite 200, Louisville, KY 40206 as Surety, hereinafter called "Surety" are held and firmly bound unto the Arizona Corporation Commission, 1200 W. **WHEREAS**, the above bound Principal has entered into a certain written agreement with Arizona Corporation Commission, for providing Wastewater Service in an area of Mohave County, Arizona.

**NOW ,THEREFORE, THE CONDITION OF ABOVE OBLIGATION IS SUCH**, that if the Principal shall indemnify and save harmless the Obligee against any loss or damage directly arising by reason of the failure of the Principal to comply with Arizona Corporation Commission Rules or Orders then this obligation shall be void; otherwise , it shall remain in full force and effect.






