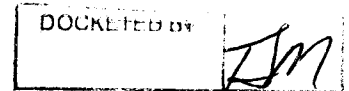

**PROCEDURAL ORDER  
EXTENDING DEADLINE FOR  
FILING EXCEPTIONS TO  
RECOMMENDED OPINION AND  
ORDER**

**BY THE COMMISSION:**

On August 29, 2011, Pima Utility Company ("Pima" or "Company") filed with the Arizona Corporation Commission ("Commission") applications for rate increases in both its water and wastewater divisions.

On September 30, 2011, a Rate Case Procedural Order was issued consolidating the applications for purposes of hearing, setting a hearing on the consolidated applications, and setting associated procedural deadlines.

Intervention was granted to the Residential Utility Consumer Office ("RUCO").

On September 28, 2012, following the conclusion of a hearing on the consolidated applications, a Recommended Opinion and Order ("ROO") was filed in this docket. The cover letter to the ROO indicated that the ROO had tentatively been scheduled for the Commission's Open Meeting to be held on October 16 and 17, 2012, and that exceptions to the ROO should be filed by 4:00 p.m. on or before October 9, 2012.

On October 5, 2012, Pima filed a Request for Extension of Deadline to File Exceptions

1 ("Request"). In the Request, Pima states that it is informed that the ROO will be scheduled to be  
2 heard on the first regular Open Meeting scheduled in November. Pima requests that the deadline for  
3 filing exceptions to the ROO be extended to October 24, 2012. Pima states that it has discussed the  
4 Request with counsel for RUCO and Staff, and that RUCO and Staff do not oppose the extension of  
5 time.

6 Pima's request is reasonable and should be granted.

7 IT IS THEREFORE ORDERED that the deadline for filing exceptions to the Recommended  
8 Opinion and Order is hereby extended to **October 24, 2012, at 4:00 p.m.**

9 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,  
10 or waive any portion of this Procedural Order by subsequent Procedural Order.
