

15 Pursuant to A.A.C. R14-3-105, Alliant Gas, L.L.C. hereby applies to the Arizona
16 Corporation Commission for an order granting Alliant Gas leave to intervene in the above
17 captioned proceeding. In support of its Application, Alliant Gas states the following:

18 1. On September 12, 2012, Alliant Gas entered into a Purchase and Sale
19 Agreement with SemStream LP, the parent company of SemStream Arizona Propane,
20 L.L.C. ("SemStream Arizona"), for the purchase of all outstanding units of membership
21 interest in SemStream Arizona.

22 2. As the buyer under the Purchase and Sale Agreement, Alliant Gas will be
23 directly and substantially affected by these proceedings. Alliant Gas, therefore, requests
24 that it be granted leave to intervene so that it can examine materials presented by
25 SemStream Arizona and Commission Staff, cross-examine witnesses and present
26 testimony and exhibits of its own, if necessary, in any hearings before the Commission.


