



**JOINT APPLICATION OF CCG COMMUNICATIONS, LLC AND LEXENT INC. FOR APPROVAL OF (1) MERGER OF CCG COMMUNICATIONS, LLC, VERODITY TECHNOLOGY PARTNERS, LLC AND VERODITY HOLDINGS, INC. WITH AND INTO LEXENT INC. AND (2) ENCUMBRANCE OF ASSETS (DOCKET NO. T-64290A-12-0373)**

In August 21, 2012, CCG Communications, LLC and Lexent Inc. ("Applicants") filed a joint application ("Application") with the Arizona Corporation Commission ("Commission"), concerning, (1) the merger of CCG Communications, LLC, Verodity Technology Partners, LLC and Verodity Holdings, Inc. with and into Lexent Inc. with Lexent Inc. as the surviving entity; and (2) the participation by Lexent Inc. in certain amended financing arrangements of Light Tower LLC. This transaction will have no effect on the rates, terms and conditions of service, and the company management and personnel will be the same and will continue to provide the same level of telephone and customer service.

It is anticipated that the Commission will issue a decision regarding the Application following consideration of the matter at a Commission Open Meeting. The Commission's Utilities Division has not yet made a recommendation regarding the Application.
