STAFF'S RESPONSE TO APS' MOTION FOR AN EXTENSION OF TIME

On October 23, 2012, Arizona Public Service Company ("APS") filed a motion with the Arizona Corporation Commission ("Commission") to extend the October 30, 2012 deadline for APS to file comments to the Utilities Division's ("Staff") Memorandum and Proposed Order filed on October 18, 2012 until November 15, 2012. While Staff does not oppose the motion, Staff notes that extending the comment deadline to November 15, 2012, would effectively preclude the Commission from considering this matter on the Commission's currently scheduled November Open Meeting dates.¹ As a result, this matter might not be heard until one of the Commission's scheduled Open Meeting dates in December.²
