PROCEDURAL ORDER

BY THE COMMISSION:

On September 24, 2010, Arizona Public Service Company ("APS" or "Company") filed with the Arizona Corporation Commission ("Commission") an application to update its Green Power Rate Schedules ("Green Power Docket").

The Commission's Utilities Division ("Staff") filed a Memorandum and Recommended Order in the Green Power Docket on May 9, 2012.

On June 29, 2012, APS filed an application with the Commission for its 2013 Renewable Energy Standard Implementation Plan ("2013 REST Docket").

Intervention in the 2013 REST Docket has been granted to Freeport-McMoRan Copper & Gold, Inc. ("Freeport-McMoRan"), Arizonans for Electric Choice and Competition ("AECC"), Arizona Competitive Power Alliance ("Alliance"), and Solar Energy Industries Association ("SEIA").

By Procedural Order issued September 28, 2012, the Green Power Docket was consolidated with the 2013 REST Docket.

On October 18, 2012, Staff filed a Memorandum and Recommended Order in the consolidated dockets.


1 On October 23, 2012, APS filed a Motion for Extension of Time. APS requests that it be
2 allowed to file its comments on the Staff Recommended Order on November 15, 2012, and requests
3 expedited consideration of its Motion.

4 On October 24, 2012, Staff filed a Response to APS's Motion for Extension of Time. Staff
5 states that it does not oppose the request, and notes that the requested extension would preclude the
6 matter from being considered on currently scheduled Open Meeting dates in November, 2012.

7 APS's request is reasonable and should be granted.

8 IT IS THEREFORE ORDERED that the **time deadline for filing comments** to the
9 Recommended Order in Docket Nos. E-01345A-10-0394 and E-01345A-12-0290 is **November 15,**
10 **2012, by 4:00 p.m.**


