PROCEDURAL ORDER

BY THE COMMISSION:

On December 27, 2011, Eden Water Company ("Eden" or "Cooperative") filed an application with the Arizona Corporation Commission ("Commission") for a permanent rate increase.

Following Eden filing additional information, on June 22, 2012, Staff notified the Cooperative that its application was sufficient and classified Eden as a class D utility.

On September 7, 2012, Staff filed a Staff Report, recommending rates and charges different than those requested by the Cooperative.

On September 21, 2012, Eden docketed a request for a two week extension of time until September 19, 2012, in order to review and respond to the Staff Report because of a delay in receiving the Staff Report.

By Procedural Orders dated September 25, 2012, and September 28, 2012, Eden was granted an extension to respond to the Staff Report, and both parties were directed to file additional comments by October 11, 2012, and to file any reply comments by October 21, 2012. In addition, the time clock was suspended indefinitely.

Eden filed a Response to the Staff Report on October 10, 2012, and Staff filed a Supplemental Staff Report on October 11, 2012.

Eden's Comments to the Staff Report raise a number of questions that would benefit from additional explanation or clarification as well as response by Staff. It appears that an evidentiary hearing would benefit the development of a complete and accurate record. Consequently, a


1 telephonic procedural conference in order to discuss a mutually convenient hearing date is set herein.

2 IT IS THEREFORE ORDERED that a **Telephonic Procedural Conference** for the purpose
3 of selecting a date for an evidentiary hearing shall commence on **November 1, 2012, at 9:30 a.m.**, at
4 the Commission's **Tucson Offices, Room 218**, 400 West Congress, Tucson, Arizona 85701.

5 IT IS FURTHER ORDERED that **parties shall contact the Hearing Division at (602) 542-**
6 **4250, and provide telephone contact numbers where they can be reached at the time set for the**
7 **Procedural Conference.**

8 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
9 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
