PROCEDURAL ORDER

BY THE COMMISSION:

By Procedural Orders dated February 7, 2012, and July 24, 2012, the hearing and procedural schedule were set in this matter. A public comment session was scheduled of October 23, 2012, a pre-hearing conference on November 1, 2012, and the Hearing to commence on November 5, 2012.

The number of witnesses and issues that remain between the Application and Arizona Corporation Commission ("Commission") Utilities Division ("Staff") as reflected in Surrebuttal Testimony are limited, and there are no outstanding procedural matters.¹ When asked on October 23, 2012, counsel for both the Applicant and Staff responded that a pre-hearing conference was not necessary. In the interest of economy, it is in the public interest to vacate the pre-hearing conference. Any procedural matters related to the conduct of the hearing can be discussed at the commencement of the hearing.


IT IS THEREFORE ORDERED that the November 1, 2012 Pre-hearing Conference is vacated.


