STIPULATION BETWEEN
ALECA AND Q LINK
WIRELESS LLC

Q LINK WIRELESS LLC ("Q LINK") and the Arizona Local Exchange Carriers Association ("ALECA") submit the following stipulation concerning Q LINK's Application in this docket.

1. ALECA has intervened in this docket in order to address potential concerns about the Application.

2. To address ALECA's potential concerns, Q LINK agrees that it will not provide Lifeline or LinkUp service to eligible residents residing on Federally-Recognized Tribal Lands in Arizona.

3. Q LINK agrees that its Lifeline enrollment application for Arizona will:

(i) Require an applicant to provide a street address, and

(ii) Include a provision that requires an applicant to self-certify under penalty of perjury that it does not reside on Federally-Recognized Tribal Lands.


4. Given the stipulation and the ILEC and zip code list for the ETC designation area filed in Q LINK's Responses to Staff's First Set of Data Requests, ALECA does not oppose Q LINK's Application in this docket and does not believe a hearing is necessary to address ALECA's concerns.
