("Company") hereby files its CAP Expense Recovery Surcharge for 2013 for the Paradise Valley Water District, as authorized by the Commission in Decision No. 59079 (May 5, 1995) and Decision No. 61831 (July 20, 1999). A copy of the tariff is attached. The revised surcharge rate is \$0.97 per customer per year based on the most recent year end customer count of 4,870 Paradise Valley Water District customers. This updated annual surcharge rate will not appear on customers' bills until January 2013. The previous effective rate was \$0.98 per customer.
