 18 **RUCO'S RESPONSE TO THE COMPANY'S MOTION TO CONSOLIDATE AND
 19 THE STAFF'S PROPOSED PROCEDURAL ORDER.**

20 The Residential Utility Consumer Office ("RUCO") hereby files its Response to the
 21 Company's Motion to Consolidate and the Staff's Proposed Procedural Order. RUCO has
 22 no objection to the Company's request to consolidate. RUCO agrees it will be more
 23 efficient to try these cases at the same time.

24 RUCO has a limited objection to the Staff's requested Procedural Order. Namely,
 RUCO requests that the deadline for filing of Direct Testimony be changed from April 29,
 2013 to May 6, 2013. RUCO has discussed the modification with both the Staff and the
 Company. Neither Staff nor the Company object to RUCO's requested modification.
 RUCO requests that the Staff's proposed procedural schedule be modified to allow direct
 testimony to be filed on May 6, 2013. Subject to approval of RUCO's requested
 modification, RUCO has no objection to the remaining deadlines proposed by Staff.
