
STAFF'S REQUEST FOR AN EXTENSION
OF TIME

On July 30, 2012, the Arizona Corporation Commission ("Commission") issued Decision No. 73285 which granted its Utilities Division ("Staff") an extension to file the Staff Report in this matter no later than December 3, 2012. The Commission also granted a corresponding extension of the February 1, 2013 time deadline in A.A.C. R-14-2-704(B) to allow the Commission to review the Staff Report and issue an Order no later than April 1, 2013.

Due to existing Staff workload and resource constraints, Staff has learned that it will require an additional eight (8) day extension to file the Staff Report in this matter. Accordingly, Staff respectfully requests that the Commission allow Staff to file its Staff Report no later than December 11, 2012. Staff does not believe that the instant request will require a similar extension of time for Commission review and determination of this matter.
