BY THE COMMISSION:


On July 2, 2012, Tucson Electric Power Company ("TEP") filed with the Arizona Corporation Commission ("Commission") an Application for a rate increase.

On November 1, 2012, the Vote Solar Initiative ("Vote Solar") filed a Motion to Intervene. Vote Solar states that it is a nonprofit grass roots organization working to fight climate change and foster economic opportunity by promoting the development of distributed solar generation, wholesale generation and solar thermal electric large-scale solar.

No party objected to the intervention.


