PROCEDURAL ORDER

BY THE COMMISSION:

On June 14, 2012, Ray Water Company, Inc. ("Company") filed an application with the Arizona Corporation Commission ("Commission") for a rate increase. The Commission's Utilities Division Staff ("Staff") notified the Company that its application was sufficient on July 13, 2012.

On July 24, 2012, a Procedural Order was docketed setting a hearing in the matter for January 16, 2013, and outlining filing deadlines.

On November 21, 2012, Staff filed a Request for Extension seeking to extend the deadlines set in the July 24, 2012, Procedural Order for filing the parties' testimony relating to cost of capital as follows:

- Staff Direct Testimony: December 19, 2012
- Company Rebuttal Testimony: January 4, 2013
- Staff Surrebuttal Testimony: January 11, 2013
- Company Rejoinder Testimony: January 16, 2013

The Company did not object to Staff's proposed cost of capital testimony filing deadlines. Staff's request is reasonable and shall be granted.

IT IS THEREFORE ORDERED that Staff's Request for Extension is granted.

IT IS FURTHER ORDERED that the filing deadlines for the parties' respective cost of capital testimony are as noted above. All other deadlines set in the July 24, 2012, Procedural Order remain the same.

1 IT IS FURTHER ORDERED that the Presiding Administrative Law Judge may rescind, alter,
2 amend, or waive any portion of this Procedural Order either by subsequent Procedural Order or by
3 ruling at hearing.


