STAFF'S REPLY MOTION

The Utilities Division ("Staff") of the Arizona Corporation Commission hereby replies to Valley Utilities Water Company's ("VUWCO" or "Company") Response to Staff's Motion to Extend Filing Due Date ("Motion"). Subsequent to the Company filing its Motion, Staff contacted VUWCO regarding a compromise position that accommodates the Company's concerns. Specifically, all of the dates set forth in the July 23, 2012 Procedural Order would remain unchanged except that Staff's Direct Testimony, which was due on December 31, 2012 would be due on January 7, 2012, and the Company's Rebuttal Testimony, which is currently due on January 18, 2012 would be due on January 25, 2012. The hearing date and the due date for all subsequent rounds of testimony would remain the same. Staff contacted the Company and Company does not oppose this modification to the procedural schedule in this matter.
